PE RELIGIOUS FASTING ACCOMODATIONS REQUEST DUE by 2/2/2026: Although students enrolled in school must engage in a required number of minutes of physical activity, AB2377 (Rivas) grants students an accommodation in connection with engaging in any physical activity components of a physical education course during a period of religious fasting upon the submission to the school principal of written notification from the pupil's parent or guardian. By completing this [FORM](#), students listed here will be provided accommodations during their period of religious fasting. A separate form must be completed for **EACH** student requesting accommodations. 9th grade students requesting a religious fast accommodation will be required to complete their state mandated physical fitness test during Office Hours in February.

IMPORTANT PARKING ENFORCEMENT NOTICE: Regular parking enforcement will be occurring across all campus parking lots and structures.
