DUE TODAY! PE RELIGIOUS FASTING ACCOMODATIONS REQUEST: Although students enrolled in school must engage in a required number of minutes of physical activity, AB2377 (Rivas) grants students an accommodation in connection with engaging in any physical activity components of a physical education course during a period of religious fasting upon the submission to the school principal of written notification from the pupil's parent or guardian. By completing this [FORM](#), students listed here will be provided accommodations during their period of religious fasting. A separate form must be completed for **EACH** student requesting accommodations. 9th grade students requesting a religious fast accommodation will be required to complete their state mandated physical fitness test during Office Hours in February.

IMPORTANT PARKING ENFORCEMENT NOTICE: Regular parking enforcement will be occurring across all campus parking lots and structures. LOST & FOUND: If you have a lost item, Lost & Found is located at the front office.

ITEM DROP OFF: The Front Office does **NOT** accept drop-offs of homework, instruments, electronics, food, projects or any other item that may be forgotten.

ON-CAMPUS FOOD DELIVERY: The Front Office does **NOT** accept food deliveries for students. PHS is a closed campus, delivery people are not allowed to deliver on campus to classrooms or any campus office or space. Students should request delivery to a specific **PHS PARKING LOT** and only during break or lunch.

ATTENDANCE (949) 936-8201: Early dismissals require a parent/ legal guardian signature or note, **calling the office to release your student is not allowed**. Please either sign the student out from the Attendance office or for a quicker release, the student may bring in a note and turn it in to the Attendance office in the morning. **Notes MUST include:** student's name, short ID#, date, time of dismissal, reason for absence and parent/legal guardian's signature. To help minimize interruptions to the classrooms, please plan appointments during break, lunch or during a free period. ***For student drivers; a note from parent/legal guardian is REQUIRED to leave campus early.**
