Tickets are not available online. Cash, checks, credit cards, and debit cards are accepted in the ASB office. A student ID card must be presented with all transactions.

RULES AND REGULATIONS

- 1. For all dances and the Spring Festival students will not be admitted an hour after the start time and may not leave until an hour is left of the event unless prior arrangements have been made. Parents will be notified if their child does not check in. If you are unable to attend, please call Mrs. Dominguez at the Activities Office (during school hours) 949–936–8239.
- 2. Our school dress code applies to school dances. Please flip to page 15 of your Portola Bulldogs agenda to view the school dress code for more details.
- 3. According to Board Policy 5144.1, "Students are to be recommended by the school principal for expulsion if they are found: Possessing, using, or being under the influence of any controlled substance, alcoholic beverage, or intoxicant of any kind." Students who are in violation of this policy will be suspended and recommended for expulsion. The sheriff will be notified, and the parents will be called to escort their child home. A breathalyzer may be used to test students suspected of being under the influence of alcohol.

- 4. Students may be checked by private security for illegal or controlled substances prior to entry to the dance area. Any student who refuses to be checked will be denied entry.
- 5. R.V.s, campers, buses, or other recreational vehicles are not allowed to be driven to the dance unless a parent or chaperone is in the vehicle. Any vehicle, including limousines, can be searched. All passengers will be held responsible and given consequences for all illegal substance in the vehicle.
- 6. Trading or selling of tickets between students are not allowed.
- 7. All students must present their student ID at the registration table on the day of the dance/festival. All guests must present their valid high school ID or a valid picture ID such as their driver's license to be admitted to the dance/festival.
- 8. Students removed or denied entry will not be given refunds. In these cases, parents will be called.
- 9. Students who are dancing inappropriately may be removed from the dance and lose privileges to attend future activities, and disciplinary actions may be taken.
- 10. Students who violate the terms of this contract are subject to suspension from school and loss of privileges to participate in any co-curricular and extracurricular activities including athletics, senior activities, and possibly commencement exercises.
- 11. No changes will be accepted to this contract.
- 12. The purchasing student must have a valid ASB card when the purchase is made in order to receive the discounted price.

I, along with my parent or guardian, have read, understand, and accept the rules and conditions listed in the contract and will comply with all of the rules for the 2019-2020 school year.

I have read both sides of this contract and agree to abide by the rules and policies of Portola High School and Irvine Unified School District. I understand the consequences for any inappropriate behavior.

I understand that these dances are school events and, like all school events, is tobacco, drug, and alcohol free. My date and I agree to remain drug and alcohol free for this event. I acknowledge that my failure to do so may result in suspension, expulsion or ineligibility to participate in extracurricular activities.
